Technicians and engineers employed in field of security system installation and maintenance have to complete the course set up by SIRA and acquire CCTV Engineer or Technician ID card approved by SIRA.

This year onwards, Video Guard, the advanced Security equipment that have been mandated in special fields resulted in improved security environment. Dubai Police has instructed SIRA approved companies to install Video Guard in institutions like banks, jewelries, commercial services, mobile sim card related outlets and financial services.

Security officials can ensure and determine all the operations of the security equipment in institutions that have installed Video Guard. The main feature of Video Guard is to notify customers and service providing companies about maintenance of security equipment.
